## Conditions of Entry for Trials

All Trials will be held in accordance with the current Rules and Regulations of the Kennel Club.

**Videography and photography will only be permitted with the express permission of the Chief Steward and the Host.**

Dogs entered at Kennel Club Licensed Field Trials must be registered with the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.

If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot.

Reserves will be approached in strict order. If a reserve cannot be contacted despite all possible efforts the next reserve will be offered the run. This decision will stand even if the original reserve appears at the Trial. No substitutions of dogs will be allowed whilst reserves still stand.

**Qualifications** Preference in the draw will be in accordance with K.C.Reg. J6i(2) and J6(j)

Please print all entry forms clearly as illegible forms cannot be accepted. Please remember to sign entry forms.

Please send a separate cheque (one for each dog entered). If entering two dogs for a Trial put them on the same entry form stating first and second choice. The KWSC may reserve to itself the right to refuse any entry.

### **Trophies**

It is the responsibility of the holder of any trophy to ensure that the said trophy is engraved, at their expense, so recording their dog's win. All trophies must be returned to the F.T. Secretary by the following September. Any loss or damage of a trophy must be reported, in writing, to the Field Trial Secretary. Certificates for all Trials will be awarded as appropriate.

### **Entries & Draw**

All draws will be carried out at the F.T. Secretary's address, as detailed in the Schedule. Members are welcome to attend to observe each draw. Directions to the venue will be sent with the result of the draw.

For withdrawals K.C. Regulation J6(f) applies. Telephone F.T. Secretary on 07486 885652.

Should circumstances so dictate, the Society, in consultation with the Judges, may alter arrangements as necessary. Such changes and circumstances surrounding them will be reported to the Kennel Club at the earliest opportunity. All persons attending these Trials must consider themselves under the control of the Chief Steward. Any bitch in season or dog suffering from hysteria must be removed from the Trial. The Kent Working Spaniel Club accepts no responsibility for injury, loss or damage to person or property, howsoever, occasioned. No modifications will be made to the schedule except by permission of The Kennel Club, followed by advertisement in appropriate journals, if time permits, before the close of entries.

Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.

All dog's resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the event can be made. All overseas entries without an Authority to Compete number will be returned to the competitor.

Dogs must be registered on the Kennel Club Breed Register or have recorded an Authority to Compete (ATC) number to be eligible to compete in a Field Trial.

### **Welfare of Dogs**

A competitor whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of the dog(s) are met, and should not knowingly put their dog's health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the General Committee for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any Field Trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the Trial.

### **Dogs in Cars on hot days**

Your dog is vulnerable and **AT RISK** if left in a vehicle in high temperatures and even on day's considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary with you bearing liability for any damaged caused.

**Loss of armband incurs a £5.00 fine.**

**Unused cheques will be destroyed.**

**Refreshments will be available for Judges, Guns and helpers. Competitors should make their own arrangements.**
